All family members must have an updated photo on file. Each member of your family is given a KEY FOB that you will scan each time you enter and exit the pool area. The purpose of your photo is to provide a visual I.D. check for the pool staff. The following information will be held confidential and is not shared with anyone else. If you have misplaced your key fob, you may purchase a new one for a \$10 replacement fee per FOB or \$25 maximum per family.
